ENTRY FORM LODGEMENT—If you wish to enter prior to Saturday 23rd July, 2022

Entries can be lodged by:-

1. SHOW BOXES AT BUSINESS OUTLETS: - Seal entry form and correct entry fee in an envelope and place in the Show Boxes at one of the above outlets with a cross beside. Entry forms are included with this schedule. Please use a separate entry form for entries in each Hall. Please keep a copy of your entry form to know what entry each exhibit card needs to be attached to. **Entries not in envelopes and containing the correct entry fee may not be accepted at the business outlets. Please ensure you read all conditions of entry and sign the entry form to confirm you have read and understood the conditions of entry.**

2. POSTING ENTRIES:- Completed entry forms can be posted to the Charters Towers Show Society, PO Box 141, Charters Towers. Qld. 4820. The envelope must be postmarked before 22nd July, 2022 - Reminder— mail can now take 1 week to arrive.

3. DROPPING TO SHOW OFFICE:- Completed entry forms can be dropped to the Charters Towers Show Society office located under the Grandstand on most week days during July up until Friday 22nd July 2022. Please phone Secretary on 0438 759 152 to find out if Office is open.

Entries will also be accepted in the Town Plaza in the Mall outside Woolworths, Gill Street Thurs 7th to Fri 8th July and Mon 11th, Tues 12th & Friday 15th July between 9am and 1pm. Entries for Sallatina Hall ONLY close at 4:00pm on Saturday 23rd July, 2022. NO LATE ENTRIES WILL BE ACCEPTED UNDER ANY CIRCUMSTANCES. EXHIBITS

WILL NOT BE ACCEPTED UNTIL SUNDAY 24th July 2022 prior to 9:00am.

Additional entry forms and schedules are also available on the Charters Towers Regional Council website.

EXHIBIT CARDS

Exhibit cards can be collected at the table in the Town Plaza from Monday 11th July to Friday 15th July and between 9am and 1pm and at Sallatina Hall on Saturday 23rd July between 10am and 4pm, or at the Show Office from Monday 18th July during business hours if entries were put in at the Town Plaza between 11th & 15th July.

Exhibit cards must be attached to all exhibits before being delivered to the Stewards in the Halls. An Exhibitors Identification number will be written on the back of all exhibit cards for easier and quicker identification by Stewards when distributing items at the end of the Show. This number will not mean anything to the judges or anyone else.

ENTRIES & EXHIBITS LODGEMENT

Entry Forms will be accepted on Saturday 23rd July 2022 between 10:00am and 4:00pm in Sallatina Hall.

No late entries will be accepted under any circumstances.

Exhibits for Sallatina Hall will be accepted on Sunday 24th July 2022 between 7:00am and 9:00am. No exhibits will be accepted after 9:00am.

Please make sure exhibits are the size stated and meet the criteria given in the Schedule. Once exhibits are in the Show, they can only be withdrawn with the consent of the Chief Steward. If you are unsure, please call the Hall Co-ordinator (Number on front cover.) Exhibits entered in the wrong classes will be changed to the correct classes at the discretion of the Hall Stewards. Charters Towers Show Society Committee reserves the right to add to, delete from or divide classes in the schedule. Your exhibits cannot be accepted until the day and times listed. We simply do not have the area to store them.

All pots must be clean and label free. All plants must have been owned by the exhibitor for a minimum 3 months before the Show.

Only 1 plant allowed in each pot unless otherwise stated.

EXHIBITS ACCESS

Entry into areas where items are exhibited is strictly prohibited. Should you need to access an item, please ask a Chief Steward or Hall Co-ordinator to assist you.

Halls will open to the public for viewing of prizes and exhibits on Monday 25th July at 8:00am. There will be no entry to either Hall for the public on Sunday 24th July.

EXHIBITS—COLLECTION OF EXHIBITS AND ANY PRIZE MONEY

Exhibits may be collected from the Hall Steward between 8:00am and 11am on Wednesday 27th July 2022. Items not collected on Wednesday by 11am will be taken to the Wallace James Hall to be collected between 1 & 5pm. Items left after Friday 29th July will be taken to the Office (under the Grandstand) and can then only be collected by making arrangements with the Show Secretary (Phone 0438 759 152). Perishable exhibits not collected by 5:00pm on Wednesday after the Show will be disposed of at the discretion of the Chief Steward. **Prize Money may be collected from the Office under the grandstand between 1:00pm and 5:00pm on Wednesday 27th July following the Show.** If you cannot collect your prize, please advise a Hall Steward and provide written authorization for another person to pickup your prize, or alternatively contact the Show Secretary (Phone 0438 759 152) to make alternative arrangements.

COLLECTION PROCEDURE FOR EXHIBITS

Go to the Steward's table and tell them your name and the section you entered. You will be given your exhibitor's entry form which you take to the Stewards who are returning exhibits. The Steward will obtain your exhibits and check off your items against your entry form. You will sign the form when you receive your items and leave with the Steward. money may be collected from the Office under the Grandstand between 1.00pm and 5.00pm on Wednesday 27th July. please advise a Hall Steward and provide a written

authorization for another person to pickup your prize, or alternatively, contact the Show Secretary on 0438 759 152 to make alternative arrangements. All prizes left uncollected for three months after judging without a valid reason, will be forfeited to the Ch Towers Show Society.

AGGREGATE PRIZES

Aggregate Prizes will be awarded to **LOCAL RESIDENTS ONLY** with the highest points score in each section. **LOCAL RESIDENTS** are those who reside in the Charters Towers Regional Council area. Points given: 1st—2 points, 2nd—1 point, Champion—3 points. If there is a tie for aggregate, the prize will be awarded to the exhibitor with the most First Prizes in that section. If there is still a tie, the prize will be awarded to the exhibitor with the most entries in the show.

PRIVACY

As a condition of entry, you authorize the collection of personal information such as name, address and contact details for the purpose of running the Show. This information will not be provided to third parties unless required in accordance with the Charters Towers Show Society Privacy Policy.

QUEENSLAND CHAMBER OF AGRICULTURAL SOCIETIES (QCAS)

TPAMA Inc. (The Charters Towers Show) is a member of the QCAS. As such, all entries are accepted subject to the rules, regulations and by-laws of the QCAS and any rules or regulations imposed by TPAMA. All exhibits must be the bona fide work/property of the individual.

WAIVER AND DISCLAIMER

The Charters Towers Show Society cannot take any responsibility for any misplaced, lost, altered, damaged or stolen exhibits given into the care and control of Stewards or Officials of the Charters Towers Show Society. It is a condition of entry into this Show and competitions that the exhibitor will hold the Association blameless and indemnified against any legal proceedings for any action or omission for accidents; injuries; loss of property, income or prize money, alteration to exhibits, wrong advice or decisions; theft; mishandling of an exhibit; incorrect attribution; defamation; non delivery or wrong delivery of exhibits. If an exhibitor is not sure of this condition of Entry and Exhibiting, then they should seek their own legal advice at their own expense, prior to entering the competition. If you have any complaints refer to Dispute Resolution section below & follow the correct procedure as stated.

DISPUTE RESOLUTION:

Anyone objecting to an award or to an exhibit in these competitions can enter a protest. This protest must be in writing and set out the grounds for objection. This objection must then be lodged with the Secretary before noon on Tuesday before the end of the Show. All protests must be accompanied by reasons for the protest and a \$50 deposit. The objection will be considered by the Dispute Resolution Committee (DRC) made up of the Charters Towers Show President, the Charters Towers Show Secretary and one (1) Charters Towers Show Executive Management Committee member. The Dispute Resolution Committee will make enquiries and report back to the parties with a decision and reasons for the decision. If the Committee finds the protest frivolous or vexatious, then it can order the \$50 forfeited and put towards next year's Show prizes. The Committee's decision is final.

ILLEGAL ITEMS: As a condition of the Show, the Stewards or Charters Towers Secretary have the right to refuse the entry of illegal or banned items being exhibited in the Charters Towers Show. The list of banned items is in the QCAS list and it includes things such as a drug referenced item and laser pointers. A full list is available for view at the Ch. Towers Show Office or it can be faxed to you on request.

FRUIT AND VEGETABLE SECTION

All fruit and vegetable exhibits must have been grown by the Exhibitor. All exhibits must be collected from Sallatina Hall before 11am on Wednesday 27th July or between 1pm & 5 pm from the Wallace James Hall after the Show. Any perishables remaining after that time will be disposed of by the Chief Steward. For other exhibits in Sallatina Hall please phone Hall Co-ordinator on 0428 513 234 to pick up by 5pm on Friday 29th July.
