### CONDITIONS OF ENTRY

ALL ENTRIES ARE ACCEPTED SUBJECT TO THE RULES, REGULATIONS AND BY -- LAWS OF THE QLD CHAMBER OF ARGICULTURAL SOCIETIES AND THE TOWERS PASTORAL, ARGICULTURAL AND MINING ASSOC.INC.

Entry fee is \$4 per exhibit per class. Please post all appropriate forms and total fees to: Boer Goats Entries, C/- Charters Towers Show PO Box 141 Charters Towers QLD 4820.

**Judging commences at 9am Tuesday**

1. UNREGISTERED EXHIBITS ARE CLASSED AS COMMERCIALS
2. **The Charters Towers Show will not be providing any food for the animals, this will need to be supplied by the owners of the animals.**
3. Declaration of Tax Status and The Charters Towers Show Waiver must be signed by all competitors.
4. Unless camping, all vehicles to be removed from the grounds prior to judging.
5. Animals may be checked for registration on arrival at the show.
6. Animals entered in Group classes must be entered in individual classes.
7. Age of animals to be actual age on the day of judging.
8. Substitute animals may be entered but only one per class and these animals **MUST** be shown on entry form.
9. All animals Must be free of disease and external parasites, and will be inspected by the Stewards before being penned. Any animal may be ordered to leave the grounds by the Stewards if necessary.
10. **DPI requires that fully completed WAY BILL accompany all stock movements.**
11. **Goats must be ear tagged in accordance with current NLIS regulations.**
12. Where there are less than 3 entries in a class, the class will be combined with another class at the discretion of the Stewards.
13. Exhibits found to be in the wrong class may be changed to the correct class by the Stewards.
14. The judge's decisions will be final and no entries worthy of a first prize in any class and may award a lesser prize instead.
15. Any person objecting to any decision made by the Judge, Stewards and/ or Committee may lodge an official protest, in writing, to the committee setting out the grounds for such protest. All official protests must be accompanied by a \$50.00 deposit, which shall be forfeited if the protest is dismissed.
16. Exhibitors passes will be issued as follows:

1 Exhibit	1 Pass
2-3 Exhibits	2 Passes
4 or more Exhibits	3 Passes

Please collect passes from sections coordinator on arrival.

17. Judging of commercial classes will take place either in the judging ring or pens at the judge's discretion.
18. Exhibits Judged to be Champions may be asked to participate in the Grand Parade and shall remain on the grounds until 8pm Tuesday 30<sup>th</sup> July unless prior arrangements have been made with the section coordinator.
19. Exhibitors should not have their stud name on any apparel when in judging ring.
20. No stud signs are to be erected at the show until judging is completed.
21. No "For Sale" signs are to be erected at all at the show. A commission of 20% is payable to the Charters Towers Show on any sales made during the Show.
22. Whilst every care will be taken to ensure the safety of exhibits entered in the Show, The Charters Towers Show will not be held responsible for any loss, injury, illness or death of any animals.
23. The Charters Towers Show will not be held responsible for any accidents or incidents that may be caused through or by an exhibit, and it shall be a condition of entry that the exhibitor will hold the Association blameless and indemnified against any legal proceedings arising from same.
24. The Chief Steward has the right to combine classes if less the 3 entries per class.
25. All exhibitors will sign a Charters Towers Show waiver form prior to competition.
