

2021 Time Travel Adventure Trail Competition | Terms and Conditions

Details:

- a. Promotion: Time Travel Adventure Trail
- b. Promoter: City of Fremantle (Visit Fremantle), PO Box 807 Fremantle WA 6959
- c. Promotional period: 10.30 am 7 January 2021 5:00 pm 20 January 2021

Conditions of entry:

- 1. To enter the competition, entrants need to complete their details on the hard-copy entry form on the Time Travel Adventure Trail map, find the answer to the four questions and record them on the entry form. Completed entry forms should be placed in the box at the Fremantle Visitor Centre at the Fremantle Town Hall, William Street, Fremantle prior to 5 pm on 20 January 2021.
- 2. One entry per child (aged 12 and under).
- 3. The prize packs will only be presented to the parent or legal guardian of the children who win.
- 4. The trail commences at 10.30 am (AWST) on Thursday 7 January 2021 and closes at 2.30 pm (AWST) on Wednesday 20 January 2021.
- 5. Entries will be accepted from 11 am (AWST) on Thursday 7 January 2021 and close at 5.00 pm (AWST) on Wednesday 20 January 2021.
- 6. Entrants must provide an email address and telephone number so that the winner can be contacted to redeem their prize.
- 7. The winners will be manually selected at random on Thursday 21 January 2021 and the draw will be conducted and witnessed by City of Fremantle staff.
- 8. There will be three (3) winning entries selected. The first winner will receive a Toyworld Fremantle voucher valued at \$500. The second winner will receive a Time Zone Fremantle credit valued at \$250. The third winner will receive a family ticket to Vikings exhibition at WA Maritime Museum (entry to Warriors of the North, Giants of the Sea and A-Viking valued at \$100), a Vikings prize pack (valued at \$100) and a Family Pass–Fremantle Prison Tour (valid for two adults and up to three children (aged 4 15 years) for a Convict Prison, Behind Bars or True Crime tour valued at \$62.00).
- 9. Prizes must be redeemed within 6 months.
- 10. Winners will be contacted by email and announced on the Visit Fremantle website https://www.visitfremantle.com.au/latest
- 11. Valid and eligible entries will be accepted during the Promotional Period. A valid entry has obtained and correctly recorded the answers to the four questions to be found at the Manjaree Trail, Fremantle Prison, Round House and WA Maritime Museum.



General conditions of entry:

- 1. Employees of the City of Fremantle, participating businesses (attractions and sponsors) and their immediate families are not eligible to enter the competition.
- 2. Eligible entrants: Entry is open to entrants who are aged 2-16. Entrants under the age of 16 must have parent or legal guardian approval to enter.
- 3. If for any reason any aspect of this Promotion is not capable of running as planned, including by reason of computer virus, communications network failure, bugs, tampering, unauthorised intervention, fraud, technical failure or any cause beyond the control of the Promoter, the Promoter may in its sole discretion cancel, terminate, modify or suspend the Promotion and invalidate any affected entries, or suspend or modify a prize.
- 4. The Promoter reserves the right, at any time, to validate and check the authenticity of entries and entrant's details (including an entrant's identity, age and place of residence). In the event that a winner cannot provide suitable proof as required by the Promoter to validate their entry, the winner will forfeit the prize in whole and no substitute will be offered. Incomplete, indecipherable, inaudible, incorrect and illegible entries, as applicable, will at the Promoter's discretion be deemed invalid and not eligible to win. Entries containing offensive or defamatory comments, or which breach any law or infringe any third party rights, including intellectual property rights, are not eligible to win. The use of any automated entry software or any other mechanical or electronic means that allows an individual to automatically enter repeatedly is prohibited and may render all entries submitted by that individual invalid.

- 12. The parent or legal guardian of the entrant(s) agrees and acknowledges that they have read these Conditions of Entry and that entry into the Promotion is deemed to be acceptance of these Conditions of Entry.
- 13. If any winner chooses not to take their prize (or is unable to), or does not take or claim a prize by the time specified by the Promoter (within 6 months), or is unavailable, they forfeit the prize and the Promoter is not obliged to substitute the prize.
