

# Redlands Coast Tracks and Trails Competition

## Terms and Conditions – Redland City Council

1. The Promoter of the Redlands Coast Tracks and Trails Competition (“the Competition”) is Redland City Council (“RCC”) ABN 86 058 929 428 of 91-93 Bloomfield Street, Cleveland, Queensland.
2. The Competition will commence on Tuesday 5 November 2019 at 10:00AM and conclude on, Friday 13 December 2019 at 5:00PM. (“the Competition Period”).
3. To be eligible, entrants must complete the following:
  - Post a photo/s in a post on the entrant’s Instagram or Facebook account, (post or account settings must be set to ‘Public’ so the post is visible to The Promoter) taken during a visit to one of Redlands Coast naturally wonderful Tracks and Trails, check-in at that location on the entrant’s Instagram or Facebook page, along with a post caption (maximum of 50 words) describing highlight/s of the entrants tracks and trails visit/experience and the post must include the #RedlandsCoast hashtag.

5. By entering the Competition Entrants are deemed to have accepted these Terms and Conditions.
